We began trip sign-up on August 1! Hopefully you are one of the early birds and have already signed up for a trip or two. If you have not signed up yet, what are you waiting for? We have published prices for all trips with the exception of Sun Valley Full Package. We are waiting (and hoping) for better air prices to Boise and expect to publish the full package price in September. All other trips have prices for land packages or full packages including air. If we are able to get a better deal on the air after you have signed up, the trip price will be recalculated and your final payment will be adjusted. You can pay your deposit either with a check sent to the TC or on-line using Paypal - the amount of the deposit is the same. However, you will get a discount if you make all other payments by cash/check. If you make any payment above the deposit amount on Paypal, you lose the cash discount. If you are still undecided about signing up for a trip, be sure and attend the September General Meeting. The

Regardless if you sign-up online at the SCSC website or signup by mailing a check to the Trip Coordinator, we need you to com-



plete the trip registration form and mail to the TC (or handover in person at a SCSC meeting, happy hour, etc). This form provides the TC with your contact information, preference of land or full package and your member number. If you don't remember your member number, look on the mailing label on your Sitzmark and you will find it after the date. This form also references the club rules on cancellation after sign-up in case you need to change your plans after signing up for a trip.
